In addition, you will take on tasks in public relations work, as well as in networking with civil society actors in Rhineland-Palatinate. The possibility of scientific qualification is given. The position does not entail any teaching duties.

As central academic institution (§ 90 HochSchG) of the University of Koblenz-Landau, the Peace Academy's main aim is to promote civil and preventive strategies for conflict and peace, crisis management as well as peace science activities in the country and at the University of Koblenz-Landau. - field research experience is desirable
- very good command of German and English, both written and spoken
